#### Copilot search no longer limited to 30-days

Before this rollout, when users asked Copilot about a long time period (such as "Summarise the key action items from March"), Copilot was limited to the last 30 days of data (left side of screenshot).

This update improves the user experience by providing more precise and relevant responses to prompts such as "yesterday," "last week," and "last month".


#### **Expanded availability for Copilot for Microsoft 365**

#### From PDF to PPT with the click of a button

With the Create from File capability of Microsoft PowerPoint, Copilot will now be able to create a new presentation based on a PDF file.

#### Information Protection labels have changed in some O365 apps

Microsoft Word, Excel and PowerPoint now have modernised labels for user-defined permission settings. The names have been changed to reflect those in the

There are new names for pre-set permissions levels, however the rights contained in each grouping are unchanged:

- Reviewer is now called Restricted Editor.
- Co-Author is now called Editor.
- Co-Owner is now called Owner.

#### Set expiration available for all links when sharing

Microsoft have now expanded link expiration capabilities from 'anyone' to internal users as well. This update means employees can set sharing durations with colleagues when information is only needed for specific and time-bound purposes, helping to keep information and assets more secure. This also helps to cement best-practice document sharing techniques with non-IT employees.

### Entra ID licence changes for multi-tenant organisations (MTO)

Microsoft has released a 'one user, one licence' update for organisations with multiple tenants. The same philosophy applies to Entra ID Governance: the organisation only needs one license per person to govern the identities of these users across these tenants.

This helps streamline procurement and alleviate complexity for your admin users, especially in highly-regulated or highly-acquisitive business environments.
